Finance/Tax Committee:

- Financial Update
 - 99.69% of the 2022 property tax has been collected, leaving an unpaid balance of \$3,285.66.
- DDA 2024 Budget
 - Council Member Terry Favors would like to move the \$20,000 budgeted for the Downtown Development Authority to repairs.
